ADOPTION	-No filing fee if filed under another Petition already pending under Chapter 26.33 RCW -Preplacement report filed prior to petition for adoption -Revocation of Consent pursuant to 26.33.160
ANTI-HARASSMENT	No charge for forms and brochures
APPEALS TO SUPREME COURT OR COURT OF APPEALS	By state or municipality  By indigent party
APPEALS, CRIMINAL RALJ	No initial filing fee - See "Criminal" below
CRIMINAL	No fee for filing - costs assessed upon conviction or plea of guilty, upon failure to prosecute RALJ appeal or affirmation of lower court conviction
DOMESTIC VIOLENCE	No charge for forms, brochures or obtaining Protection Orders
DOMESTIC VIOLENCE	No charge for filing or service of process; No charge for certified copies to petitioners
EMANCIPATIONS	No charge for <b>one certified copy</b> of Decree to Petitioner.
EMINENT DOMAIN	See Condemnation
EMPLOYMENT SECURITY	(Judicial Review on Unemployment Compensation) - No fees of any kind chargeable to individuals - No fees for department for any of Clerks services
FORMS AND BROCHURES	No fee for forms and brochures under the Domestic Violence Act, the Anti-Harassment Act or the Sexual Assault Protection Act
GUARDIANSHIP OR LIMITED GUARDIANSHIP	- No fee for filing when assets less than \$3,000.00 - No prepayment when filed by AG - may be ordered paid by estate
GUARDIANSHIP TO ESTATE	Cause Code migration/ no additional fee is charged to transfer the guardianship file to a probate proceeding when migration is ordered
IRRIGATION DISTRICT	No fee for Oath of Comm/Board Member of Joint Irrigation District
IN FORMA PAUPERIS	Waiver of filing fee due to financial hardship
INTERPLEADER/ DISCLAIMER RE DISPUTED PROPERTY/FUNDS	Upon deposit of money into clerk's trust account, no filing fee is required. Filing fee may be assessed by the Court upon resolution of case
MENTAL ILLNESS JURY	No jury fee

RELINQUISHMENT OF A CHILD	No filing fee to a department, agency or prospective adoptive parent under RCW 26.33.080
SERVICE PERSONNEL	No fees for copies of Decrees of Dissolution or other documents affecting the marital status of service personnel of US armed forces (for determining entitlements to family allowances and other benefits)
SEXUAL ASSAULT PROTECTION	No filing fee. No fees for forms or certified copies
SOCIAL & HEALTH SERVICES	- Judicial review, no filing fees for individuals - Exempt from filing and copy fees relating to paternity or support
UNEMPLOYMENT COMPENSATION	See Employment Security
VETERANS	(Marital Status) No fees for copies for family or legal representative of deceased for VA or other governmental agencies when required in connection with any claim pending before Veterans' Bureau or governmental agency administering benefits to war veterans
VETERANS	(Pension, Bounty, Back Pay) No fee for administering oaths, preparing official certificate or perfecting a voucher to procure a pension, bounty or back pay for Honorably Discharged, or spouse, orphan or legal representative
VETERANS	(VA Administration For Benefit Eligibility) No charge for copies to VA, applicant or person acting on applicant's behalf
VULNERABLE ADULT PROTECTION	No filing fee. No fees for forms.
