Welcome to a unique area of Whidbey Island, the northwest, and the Nation! Your property lies within Ebey's Landing National Historical Reserve, our country's first historical reserve, established by Congress in 1978 and a unit of the National Park system.

You may have moved here for some of the same reasons that the local community worked to establish the Reserve. Many only know that they like the area very much and sense its extraordinary qualities and characteristics. The pace of change has increased on the island due to population growth. We need to work together to maintain the Reserve's unique environment.

The cultural landscape is the key to understanding what the Reserve is all about. The prairies and woodlands, the dramatic coastline and quiet coves, the historic architecture and heritage farms, and the open space and scenic views work together to create a mosaic of natural and historical features. The central Whidbey community values its history that remains a visible and active part of everyday life.

In order to preserve and protect our cultural landscape, Island County's Historic Zoning Ordinance created the Central Whidbey Island Historical Preservation District Review Committee (HRC). This committee empowers citizens and professionals to review all improvements within the Reserve to ensure that new development respects the historic patterns of settlement, architectural character and economic investment that now exists in the Reserve. The HAC invites all applicants to a pre-application meeting for free planning assistance. These early meetings save valuable permitting time and money. The HAC meets the first and third Tuesdays of each month at 8:30 a.m. and 4:00 p.m. respectively. Please join us at either meeting.

We look forward to working with you in preserving the cultural landscape that is Ebey's Landing National Historical Reserve. We hope your project may inspire future applicants to design new development that blends with the landscape and enhances the quality of life in this national treasure we call home.

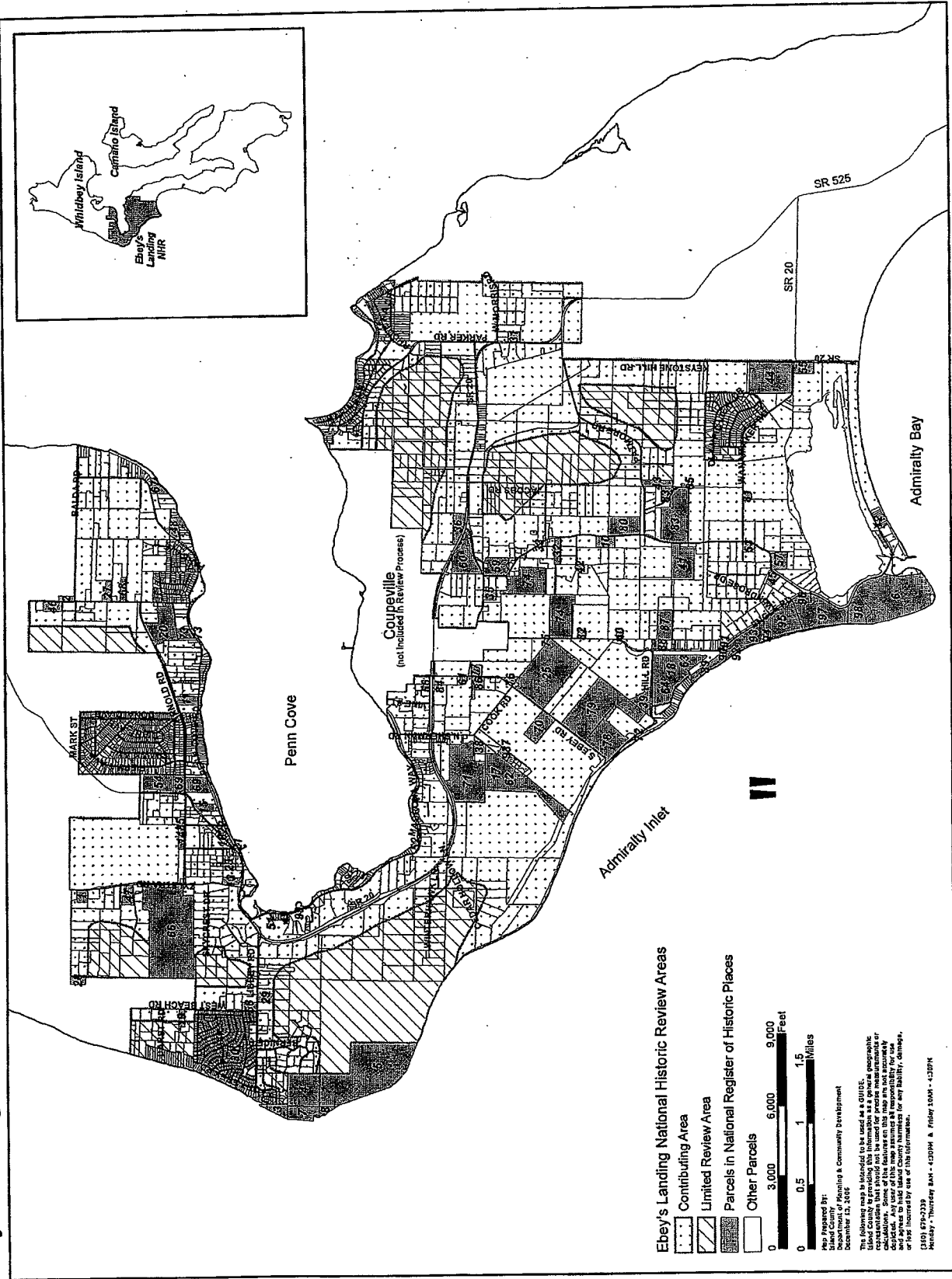

  - 3. Clearly identify existing and new elements.
