PUBLIC NOTIFICATION **SEX OFFENDER RELEASE** **LEVEL 3 HIGH RISK TO THE COMMUNITY**

The Island County Sheriffs Office is releasing the following information pursuant to RCW 4.24.550 and the Washington Supreme Court decision in State v. Ward.

In August 2001 EVANS met a 12 year-old-female for the first time when she visited mutual friends. She told him her age, however, he forcibly engaged her in sexual intercourse. He was sentenced to 29 months in a state prison concurrent with two other felony convictions that he served releasing on 04.16.2003. EVANS has not participated in sexual deviancy treatment.

EVANS was classified by DOC as a Level 2 offender in 2003. Based on his history and other assessments EVANS has been rated at a Level 3. EVANS is required to register with the Sheriffs Office in the County of his residence for 15 years, or until relieved by the Courts of the duty to do so.

EVANS is currently under the Department of Corrections community supervision for a different offense.

This offender has served the sentence imposed by the Courts and is NOT WANTED by law enforcement at this time. Law Enforcement agencies do not have the legal authority to direct where an offender lives.
