# SEX OFFENDER RELEASE

## LEVEL 3 ~ HIGH RISK TO COMMUNITY

The Island County Sheriff's Office is releasing the following information pursuant to RCW 4.24.550 and the Washington State Supreme Court decision in State v. Ward.

**Level 3 Sex Offender**

This offender has been convicted of a sex offense. He has served the sentence imposed by the Courts, and is **NOT WANTED**.

**CHRISTOPHER A. MAZDRA**

**CHRISTOPHER A. MAZDRA** was *Found Guilty* by jury trial of 3 counts of Rape of a Child - 3<sup>rd</sup> Degree on Feb. 10, '06 in Island County Superior Court, and sentenced on May 18 '06 to 9 months for each felony count (to be served concurrently) and received Special Sexual Offense Sentencing Alternative (SOSSA). He was released from the County Jail on his sentencing date for "time served", having been in custody since Aug. '05. MAZDRA was then transferred to the Oak Harbor Police Dept's Municipal Jail, to serve time for a separate offense -- **Communicating with a Minor for Immoral Purpose** (convicted Jan. '06.) He was subsequently released from the City Jail on May 19<sup>th</sup>, following the Court's determination that the time already served by MAZDRA in the County Jail was sufficient to also include the separate, 10-day sentence.

In 2003, MAZDRA -- then 24 years old -- initiated a sexual relationship with a 14-year-old girl whom he had befriended while riding a transit bus in the Oak Harbor area. The relationship lasted about 5 months, with MAZDRA often meeting his victim at a public library. MAZDRA sexually molested the girl on three separate occasions, in his family home. In 2005, MAZDRA met a 13-year-old physically handicapped girl -- also on the bus and at the library -- and engaged her in conversation and Internet contact. He attempted to entice her into a more intimate relationship but was unsuccessful due to parental intervention and reporting to the police.

For his conviction of Communicating with a Minor for Immoral Purposes, MAZDRA is under supervision of Island County District/Municipal Court. In addition, for his conviction of Child Rape -- 3<sup>rd</sup> Degree (3 counts), MAZDRA is under 60 months of community supervision by the WA State DOC (Dept. of Corrections). MAZDRA is required to attend and complete sex offender treatment; have no contact with minor children of any gender, or frequent public libraries, bus stops or other areas where children congregate; not consume alcohol or use illegal drugs; and to have his compliance with all required court ordered conditions reviewed every 90 days by Island County Superior Court.

The Island County Sheriff's Office has rated MAZDRA as a Level 3 Sexual Offender, with a high potential or risk to the public of re-offending. This assessment is based upon MAZDRA'S history, records, and other assessments. He is required to register with the Sheriff's Office in the County of his residence for life, or until relieved by the Courts of the duty to do so. MAZDRA has served the sentence imposed upon him by the Courts and is **NOT WANTED** by law enforcement at this time.
