# SEX OFFENDER RELEASE

## LEVEL 3 – HIGH RISK TO COMMUNITY

The Island County Sheriff's Office is releasing the following information pursuant to RCW 4.24.550 and the Washington State Supreme Court decision in State v. Ward.

This offender has been convicted of a sex offense. He has served the sentence imposed by the Courts, and is NOT WANTED by law enforcement at this time.

Law Enforcement agencies do **not** have legal authority to direct where an offender lives.

**GLENN W. JOLLEY was found GUILTY of INDECENT LIBERTIES in Island County Superior Court on Nov. 5 '01. JOLLEY sexually molested an adult female patient in Jan. '01, while JOLLEY was working as a private therapist, or domestic relations counselor, at his Oak Harbor practice. JOLLEY touched the victim in a sexual manner without her permission, and appeared to be sexually aroused. JOLLEY was sentenced to 18 months in a State Prison; he has served 12 months, and will be released on Nov. 18 '02, to remain under WA Dept. of Corrections (DOC) community supervision ("parole") for 36 months.**

Over the past 10 years, other female patients, adults and juveniles, have alleged that JOLLEY engaged in sexually abusive behavior while treating them at his private practices in King, Snohomish and Island Counties (Freeland and Oak Harbor). During the Nov. '01 criminal trial, JOLLEY was found not guilty of a second complaint of Attempted Indecent Liberties, and the jury was "hung" on a third complaint of Rape – 2<sup>nd</sup> Degree, each involving different victims.

Based upon State standards and evaluations, JOLLEY was rated by DOC and the Island County Sheriff's Sex Offender Classification Review Board as a Level 3 Sex Offender, with a high potential to re-offend. JOLLEY is an untreated sex offender. JOLLEY is required to register with the Sheriff's Office in the County of his residence for 15 years, or until relieved by the Courts of the duty to do so.

JOLLEY has served the sentence imposed upon him by the Courts, and is **NOT WANTED** by law enforcement at this time. While under DOC Supervision for 3 years, JOLLEY shall not have contact with his victim, hold any position of trust or authority over any minor or adult except his immediate children, provide counseling services, or consume alcohol, and shall complete sexual deviancy evaluation, and follow other conditions.
